MEMORANDUM OF UNDERSTANDING BETWEEN

Rajkiya Engineering College, Ambedkar Nagar (U.P.)

AND

Madan Mohan Malaviya University of Technology, Gorakhpur

This Memorandum of Understanding (MoU) is executed on October 10, 2025

Between

Rajkiya Engineering College, Ambedkar Nagar (hereinafter referred to as REC, Ambedkar Nagar) of the FIRST PARTY, was established by Government of Uttar Pradesh under special component plan in year 2010 with a view for making it a leading Technical INSTITUTE to become a Centre of Excellence with focus on Research and Development and Incubation in the field of Engineering & Technology and other professional courses. REC, Ambedkar Nagar aims to promote studies, research & innovation in Engineering areas of higher education, to enhance skill development through continuing education programmes and knowledge and to achieve excellence in higher technical education.

Madan Mohan Malaviya University of Technology, Gorakhpur (hereinafter referred to as MMMUT) has been established in the year 2013 by the Government of Uttar Pradesh in the form of a non-affiliating, teaching and research University after reconstituting the Madan Mohan Malaviya Engineering College, Gorakhpur, which was established in 1962. In addition to UG in Civil Engineering, Chemical Engineering, Computer Science & Engineering, Mechanical Engineering, Electrical Engineering, Electronics & Communication Engineering, Information Technology, the University also offers MCA, BBA, MBA, M. Tech, M.Sc. and Ph.D. courses in various specialisations. It has entered the league of top educational institutions of India by achieving 99th in overall NIRF ranking, 68th ranking among the Universities, 60th in Engineering, 83rd Ranking in Management, and 23rd NIRF Ranking among the state public universities of the country, and also acquired NAAC Grade A rank, and is the SECOND PARTY.

PREMABLE

Rajkiya Engineering College, Ambedkar Nagar (REC, Ambedkar Nagar) and Madan Mohan Malaviya University of Technology, Gorakhpur (MMMUT, Gorakhpur) recognise their strengths in research and education in one or more disciplines of science, engineering, and management, and their mutual interest in engaging themselves in academic cooperation.

REC, Ambedkar Nagar and MMMUT, Gorakhpur, therefore, agree to establish a programme for academic cooperation in the areas of mutual interest, and in accordance with the terms and conditions set forth in this memorandum of understanding (MoU).

A. Objectives

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions. REC, Ambedkar Nagar and MMMUT, Gorakhpur agree:

- a) to exchange information on research and educational programmes
- b) to exchange information on teaching, learning material and other literature relevant to their educational and research programmes
- c) to jointly organize short-term continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein
- d) to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein
- e) to jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein
- f) to exchange, on a reciprocal basis, students at Undergraduate, Graduate and Doctoral levels for limited periods of time for the purpose of education and /or research.

REC, Ambedkar Nagar and MMMUT, Gorakhpur, further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

B. Joint Sponsored Research, Development and Consulting

REC, Ambedkar Nagar and MMMUT, Gorakhpur agree to help identify and invite faculty members from the other institution to participate in research or development programmes. The terms and conditions for such participation will be worked out by mutual agreement between REC, Ambedkar Nagar and MMMUT, Gorakhpur.

C. Exchange of Faculty and Staff

REC, Ambedkar Nagar and MMMUT, Gorakhpur agree to encourage collaboration between faculty from the two institutions. Specifically, institutions will encourage members of their faculties to undertake short visits to or take up fixed-term visiting assignments at, each other's institution as per the existing norms. Terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, name of the concerned faculty member will be worked out between REC, Ambedkar Nagar and MMMUT, Gorakhpur. Notwithstanding the above, REC, Ambedkar Nagar and MMMUT, Gorakhpur will examine ways to identify financial resources to fund international travel by their faculty/scientists/students.



D. Student Exchange

REC, Ambedkar Nagar and MMMUT, Gorakhpur agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

- a) Exchange students will be selected by mutual agreement between the home institution and the host institution.
- b) An exchange student will continue to be treated as full-time student at his/her home institution.
- c) An exchange student will be considered as full-time "exchange" student at the host institution.
- d) His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.
- e) The host institution will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter to that effect.
- f) The home institution may award to the exchange student credits earned at a host institution, but only after the home institution has established correspondence between courses taken at the host institution vis-a-vis those offered at the home institution.
- g) If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- h) If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report and take steps in accordance with its own procedures.
- i) REC, Ambedkar Nagar and MMMUT, Gorakhpur agree to provide suitable accommodation and living expenses for student exchange.
- j) To avail travel expenses, students can apply for existing funding programs at their respective home universities.
- k) The exchange students will pay tuition and other fees at their home institution.
- l) Exchange of Scientific and Technical Material

REC, Ambedkar Nagar and MMMUT, Gorakhpur will exchange information on research and educational programmes and teaching/learning material and other literature relevant to their educational and research programmes. Further, REC, Ambedkar Nagar and MMMUT, Gorakhpur agree to explore ways to share teaching/learning material, and other relevant literature, while respecting each other's intellectual property and other rights.

F. Joint Conferences, workshops and short-term courses

REC, Ambedkar Nagar and MMMUT, Gorakhpur agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short-term courses. The terms and conditions for such participation will be worked out by mutual agreement between REC, Ambedkar Nagar and MMMUT, Gorakhpur.



G. Intellectual Property

REC, Ambedkar Nagar and MMMUT, Gorakhpur agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

H. Co-ordination

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of (a) Director, REC, Ambedkar Nagar, or his/her nominee, (b) Vice Chancellor, MMMUT, Gorakhpur, or his/her nominee, (c) Programme coordinator from the side of Director, REC, Ambedkar Nagar, and (d) Programme Coordinator from the side of MMMUT, Gorakhpur, will periodically review and identify ways to strengthen cooperation between the two institutions.



I. Tenure and Termination

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for five years, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither REC, Ambedkar Nagar nor MMMUT, Gorakhpur will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, REC, Ambedkar Nagar and MMMUT, Gorakhpur will ensure that all activities in progress are allowed to complete successfully.

J. Arbitration

Clause Should there be a dispute relating to any aspect of academic cooperation, Director, REC, Ambedkar Nagar and Vice Chancellor, MMMUT, Gorakhpur will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

This MoU is signed subject to approval of the respective academic/administrative bodies.
